# Minutes of a meeting of South Hinksey Parish Council on Monday 3<sup>rd</sup> December 2007 in the Village Hall, South Hinksey.

Before the Parish Council meeting the Parish Council met with representatives and Trustees of the Village Hall Management Committee to discuss financial contributions that the Parish Council may like to make to the Village Hall in future years.

Before the meeting of the Parish Council the Council were addressed by the Chairman, Trustees and Village Hall Committee members of South Hinksey Village Hall with regard to the financial situation of the Village Hall.

## 108/07 Apologies for Absence

**RESOLVED** to note that there were no apologies for absence.

## 109/07 Declarations of Interest

To receive declarations of any personal or prejudicial interest under consideration on this agenda in accordance with the Parish Councils (Model Code of Conduct) Order 2001.

## 110/07 Co-option of a Parish Councillor

Members noted the casual vacancy on the Parish Council was still vacant and were asked to consider filling the vacancy by co-option as soon as practicable.

Councillor Mrs Rawcliffe had invited a prospective Councillor to attend the meeting.

## 112/07 Woodland Project Proposal

Councillor Briffett reported that the Woodland Project had secured a grant of £10,000 from the Trust for Oxfordshire's Environment and £500 from the Doris Field Foundation. A third grant from the Forestry Commission had yet to be confirmed.

Councillor Briffett was advised by the Parish Clerk that work could not start on the woodland as outlined at previous meetings because the Parish Council had not yet formally accepted the quote for the necessary tree purchases and future maintenance.

**RESOLVED** that Councillor Briffett would draft a letter for the Parish Clerk to send accepting the quote for the work. The grants were to be paid to the Parish Council who would be the bank for the community project.

There was a small amount of money available from FOSH left over from the Millennium Fund which would be forwarded to the project.

The Friends of the Kennington Community Woodland Project had invited parishioners and the Parish Council of South Hinksey to join them on a Friends Day on the 13<sup>th</sup> December 2007. Councillor Mrs Rawcliffe is a Friend of Kennington Community Woodland and members agreed that a Friends of South Hinksey Woodland should be set up.

## 113/07 Sale of Land off Chilswell Path to Mrs M. Pringle

The Parish Clerk would follow this matter up.

## 114/03 Community Land Proposal

Councillor Mrs Rawcliffe reported that Peter Rawcliffe had discussed this matter further and sent further copies of the correspondence to Oxford City Council. A strip of 30m x 50m would have to be left to allow access for Peter Burrows. Members noted that a response was being awaited.

## 115/07 Members Responsibilities

Members noted the proposals with regard to Members responsibilities as a Parish Councillor within South Hinksey and **RESOLVED** that the Parish Clerk should return it to a table for presentation at the next meeting.

## 116/07 Planning Applications

The Parish Clerk reported that as yet the new owners of the land that had just been sold adjacent to the public house had not registered the land. She was asked to see if she could obtain an accurate site plan of exactly which area had been sold to ensure that should any future planning application be submitted then the new owners of the land do not put in an application on any land which they do not own.

## 117/07 Budget 20078/2009

**RESOLVED** that the Parish Clerk would bring a draft budget to the January meeting of the Parish Council for consideration.

Members asked that a small sum be put in for cutting back of hedgerows/overhanging branches that may be necessary, £1000 for the Village Hall and a sum, to be earmarked, to commence a fund for future maintenance of the Community Woodland for when all grants run out.

## 118/07 OBGN AGM

**RESOLVED** to note that Councillor Briffett had drafted a letter for the Parish Clerk to send to the Prime Minister on behalf of the parish Council with regard to the Oxford Green Belt. Members had all seen and approved it to be sent.

Members noted the attached presentation notes from a presentation made by Martin Harris on the proposed "Urban Extension of South Oxford"

## 119/07 A34

Following the meeting held on 1<sup>st</sup> August the Parish Clerk has re-written to the Highways Agency but to date no response had been received.

Councillor Briffett recorded a vote of thanks to Linda Goodhead, a member of the FOSH Committee, who had attended a meeting of the Traffic Advisory Committee at Botley. The Parish Clerk expressed disappointment that she had not been given the opportunity to attend as a representative of the Parish Council. She would write to the Clerk to the Committee asking that in future that the Parish Council is made aware of the meetings.

## 120/07 Flooding matters.

Peter Rawcliffe had set up a local Flood Group as a pressure group to the Environment Agency and the Government. Councillor Mrs Rawcliffe had attended the Flooding Meeting which turned out to be more of a meeting of people selling flood defences etc for the home.

## 121/07 Village Hall Management Committee

**RESOLVED** that following the presentation made to the Parish Council before the meeting that the Parish Council would make a donation of £500 for the 2007/2008 financial year and a grant of £1000 for the 2008/2009 financial year.

Any future grants would be considered on their own merits and the Village Hall Management Committee had been invited to address the Parish Council at a similar stage next year for consideration of a grant within the 2009/2010 budget.

**RESOLVED** that this item be deferred to the Parish Council Meeting in January. This gave members the opportunity to consider the paperwork circulated with the agenda with regard to the introduction of a new national standard planning application form, called 1APP.

## **RESOLVED** to note the following:

 Ref: 105/07 VOWH Consultation – Open Space, Sport and Recreation Provision Strategy and a Draft Supplementary Planning Document.

Cllr. Davies had made the following observations:

On reading these reports I do not think that it will involve us as a council, it mainly concerns the planning authorities and developers constructing 15 or more dwellings.

However within this document there is reference to the Vale of White Horse Council's Core Strategy on which the council proposes to base its Local Development Framework. This identifies 21 sustainability objectives which the Council considers to be relevant to the proposed SPD. These objectives include Reducing the Risk of Flooding, Reduce Road Congestion and its associated pollution.

I presumed that the moneys raised from the developers will be used to help maintain all existing green spaces and sports facilities as well as any new areas. The document does not make that clear.

Councillor Briffett requested to read the information document and would liaise with Councillor Davies as to a suitable response from the Parish Council.

## · Grass Cutting in Church Close

The Parish Clerk was contacted by Cllr. Mrs Rawcliffe with regard to the grass being cut in a haphazard way leaving clippings over the path, which became slippery when wet. The grass cutting is now finished for the season but our comments and concerns have been taken into account for next year however members are asked to monitor the situation.
